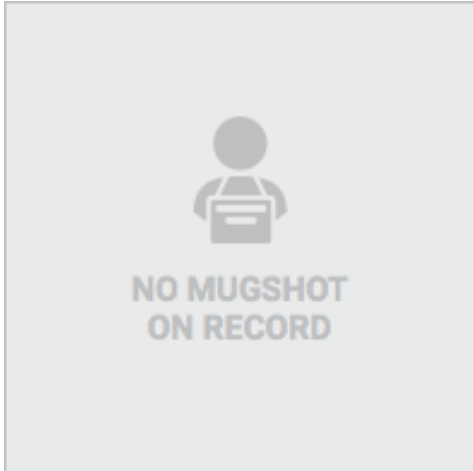

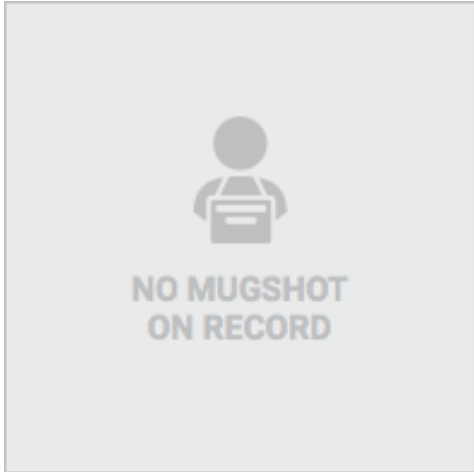

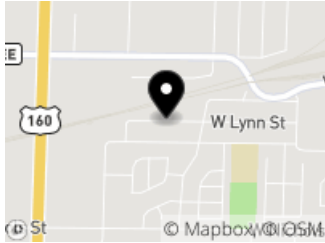


The estimate for 2015 bankruptcies is around 800,000, which is a decline of 12% from last year.
